Abstract (en)

The socks (10) as a foot part (12) surrounding the foot and a bootleg part (14) surrounding the leg. A band (16) is arranged at the bootleg part, is placed around the leg and is fixed above a closure based on appropriate prestressing into a position. The belt comprise a Velcro(RTM: hook and loop fastener) or a press-stud fastener. The belt is selected form a material such as fabric, felt, leather or plastic. The belt is formed as a two part belt, and the foot and bootleg parts are connected with the leg. An elastic region is formed at an upper end of the bootleg part.

Die vorliegende Erfindung betrifft Babysocken (10) bestehend aus einem ersten den Fuß umgebenden Fußteil (12) und einem zweiten das Bein zumindest teilweise umgebenden Schafteil (14), wobei am Schafteil (14) zumindest ein Band (16) angeordnet ist, das um das Bein legbar und über einen Verschluß oder aufgrund eigener Vorspannung in dieser Lage fixierbar ist.
