Abstract (en)  
The present invention relates to a smokable material comprising at least a reagent capable of interacting with CO<sub>2</sub> physically and/or chemically, leading to a CO<sub>2</sub> removing from the mainstream of smoke during the smoking of the smokable material. The present invention also relates to a smokable article comprising a smokable material (1), to a filter, for example a solid filter or a liquid filter, and to a sealed casing.
