[origin: WO2008148967A2] The invention relates to a pharmaceutical or cosmetic composition for topical and/or parenteral application, containing, in a physiologically acceptable medium, at least one retinoid or the salts and derivatives thereof and at least one hyaluronic acid oligomer selected from among compounds containing between 1 and 6 disaccharide units. The invention is particularly suitable for use in human dermatology and plastic surgery.
