Abstract (en)

[origin: EP2159296A1] The invention relates to a quench hardened and tempered steel with a specific composition of the following elements: 0.22% # C # 0.30%, 0.40% # Mn <1.00%, 1.00% # Cr # 2.50%, 1.80,% # Ni # 4.00%, 0.30% # Mo < 0.90% and 0.01 % # V < 0.50%, which with a method for obtaining said steel achieves low P and S contents, contributes to increasing the mechanical strength of the steel to values greater than 1200 N/mm² and with high toughness, KV resilience at low temperature, -20°C, with values greater than 60 J, when a part for the manufacture of which said steel has been selected is subjected to a specific quench hardening and tempering treatment.
