[origin: WO2009006260A2] A method for filter generation includes a first clause of a filter described in a user interface. A filter is generated responsive to receiving a description of at least one of: i) a conjunctive clause of the filter, and ii) a disjunctive sub-clause of the first clause. In another aspect, a method for access routing includes determining whether to provide access to a resource by a server according to a requested method, responsive to a rule. In another aspect, a method for interactive policy evaluation includes displaying a result of applying a policy to at least one of: a description of a client requesting access to a resource, a description of the resource, and a description of a requested access method. In another aspect, a user interface displays a result of an application of a policy to a client responsive to a received identification of a client characteristic.
