Abstract (en)

Preparing a composition, preferably a medicament, comprising a combination of calcium acetate and magnesium salts, comprises: (a) providing particulate calcium acetate granulate, which is produced by fluidized bed granulation; (b) providing a particulate magnesium salt component; (c) producing a mixture using the calcium acetate granulate and the magnesium salt component; and (d) processing the produced mixture to an administrable product, preferably orally administrable formulation, preferably medicament form. Independent claims are included for: (1) the composition, preferably medicament, obtained by the above process; (2) a process for producing particulate calcium acetate, in which the calcium acetate is produced in the form of calcium acetate granulates by fluidized bed granulation; and (3) a particulate calcium acetate, obtained in the form of calcium acetate granulate using fluidized bed granulation. ACTIVITY : Nephrotropic; Metabolic; Cardiovascular-Gen.; CNS-Gen.; Gastrointestinal-Gen. MECHANISM OF ACTION : None given.

Abstract (de)

Die Erfindung betrifft ein Verfahren zur Herstellung einer Zusammensetzung, insbesondere eines Arzneimittels zur proplayaktischen und/oder therapeutischen Behandlung von mit renalen Dysfunktionen, insbesondere Niereninsuffizienz, einhergehenden Erkrankungen und/oder Störungen, wie Hyperphosphatämie und/oder Hypercalcämie, sowie eine auf diese Weise hergestellte Zusammensetzung und deren Verwendung. Die Zusammensetzung weist eine Kombination von Calciumacetat einerseits und Magnesiumsalz andererseits auf.
