[origin: WO2008148227A1] The invention relates to a method for interaction between a user (32, 24), for example, a newspaper publisher, and at least one receiver (A, B, C) to whom a printed product (12, 23, 23a, 23b, 23c, 26) comprising at least one RFID tag (14, 14a, 14b, 14c) is delivered. At least one specific piece of additional information (a, b, c, 42) is stored in the at least one RFID tag (14, 14a, 14b, 14c) for the purposes of interaction.
