[origin: WO2009019385A1] The invention relates to the use of at least one of the compounds (S)-2-dodecylsulfanyl-N-(4-hydroxy-2,3,5-trimethyl-phenyl)-2-phenyl-acetanilide (eflucimibe) of formula (I), (R)-2-dodecylsulfanyl-N-(4-hydroxy-2,3,5-trimethyl-phenyl)-2-phenyl-acetanilide ((R) enantiomer), and the pharmaceutically acceptable salts and solvates thereof for producing a medicament or a dermatological composition for preventing and treating disorders caused by sebaceous gland dysfunction and/or any state or disease related to excess sebum production in humans or animals.
