Abstract (en)
[origin: CA2693618A1] The invention relates to an illuminated dispenser (10) for a liquid (3) with at least one light source (5, 6), wherein, when the dispenser (10) is actuated, the at least one light source (5, 6) is switched on for a predetermined time and illuminates the liquid (3) dispensed and/or the liquid (3) kept in the dispenser (10). The invention also relates to a method for illuminating a dispenser (10) for liquids (3) with at least one light source (5, 6), characterized by the steps of converting the mechanical energy that is produced when the dispenser (10) is actuated into electrical energy by means of an energy generator (2), and emitting the electrical energy to the at least one light source (5, 6) for the operation thereof. The invention also relates to an illuminated bottle closure (20) for a hollow body with at least one light source (5, 6), and a battery (7), wherein, when a switch (1) is actuated, the at least one light source (5, 6) is switched on for a predetermined time and illuminates the liquid (3) kept in the hollow body.
