Abstract (en)

The present invention relates to a CO₂-generating device for use with a beverage included in a beverage container or beverage dispensing system, in particular a draught beer system. The CO₂-generating device comprises a CO₂-generating chemical system including two distinct chemical compounds constituting a first chemical compound and a second chemical compound for generating CO₂ through chemical reaction when mixed together. The CO₂-generating device further defines a pre-activation stage in which the first and second chemical compounds are being stored separately relative to one another, and a post-activation stage, in which the first and second chemical compounds are being at least partially mixed together.
