Abstract (en)

In a monitoring system of a power wheelchair (low-speed mobility vehicle 12) and an automobile (vehicle of different type 14) having a remote monitoring device (16) connected to them through a first communicator (46), each of the wheelchair and automobile includes a first transmitter (42, 72) transmitting location data to the remote monitoring device through the first communicator, and the remote monitoring device calculates an inter-vehicle distance between the wheelchair (12) and automobile (14) based on the location data and transmits an approaching signal indicating that they are approaching each other when the inter-vehicle distance is equal to or less than a first predetermined value, thereby reducing the driving burden on the operators and enhances driving safety.
