Abstract (en)

[origin: WO2009056456A1] The invention relates to a water-carrying household appliance, particularly a dishwasher or washing machine, comprising at least one strain relief device, particularly for a double hose of a water-carrying household appliance, comprising at least a first partial strain relief device (2, 62) comprising a first receptacle (5) for a first hose and a second receptacle (6) for a second hose running within the first hose, and a second partial strain relief device (3) comprising a third receptacle (5a) for the first hose and a fourth receptacle (6a) for the second hose running within the first hose, wherein the first and/or the third receptacle (5, 5a) comprises strain relief means (8, 8a) for the first hose and the second and/or the fourth receptacles (6, 6a) comprise strain relief means (11, 11a) for the second hose, and the two partial strain relief devices (2, 62; 3) are connected to each other such that the first and third receptacles (5, 5a) encompass the first hose and the second and fourth receptacles (6, 6a) encompass the second hose in the installed condition, and the second hose is fed through the two partial strain relief devices (2, 62; 3).
