Abstract (en)
[origin: WO2009065823A2] The invention relates to a textile treatment agent containing a biocidal compound, a perfume composition and a non-ionic surfactant, said non-ionic surfactant having an HLB value of between 10.5 and 15 and precipitation threshold of at least 50 °C. This permits the production of a stable textile treatment agent which reduces the number of micro-organisms on textiles treated with said agent and gives the textiles a pleasant fragrance.
