[origin: WO2009068267A1] The invention relates to a chamber wall (3) for a drying chamber or a combustion chamber or a tunnel furnace for the production of components (16) made of ceramic or similar material. In order to create a simple and quicker construction capable of dismantling, or to enable the disassembly of the chamber wall (3a), the chamber wall (3) is made of wall modules (3a) that are disposed one behind the other in the longitudinal direction thereof.
