[origin: CA2713087A1] The invention relates to a film, in particular for an adhesive tape, characterized in that the film contains at least one homopolymer, copolymer, or terpolymer of the propylene and fibers and is monoaxially stretched in the longitudinal direction, wherein the elongation ratio is preferably at least 1:8 and particularly preferably at least 1:9.5.
