[origin: WO2009136047A1] Method of electronic voting in a questionnaire, comprising: - a step of broadcasting an offer of electronic voting service to a plurality of communications terminals; - a step of dispatching from a communication terminal of a voter, a request to a remote server, this request containing information for authenticating a voter; - a step of authenticating the voter by comparing the authentication information received with recorded information associated with the voter; - when the voter has been authenticated, a step of dispatching to the communication terminal of the voter a ticket to participate in the vote; a step of dispatching the vote to the server, the former containing a response to the questionnaire and the ticket to participate in the vote, this method being characterized in that it comprises two steps of anonymization, a first step ensuring anonymization to the ticket to participate addressed to the voter by the server, a second step ensuring anonymization of the communication terminal addressing the response to the vote to the server, the participation ticket containing at least one item of data associated with the profile of the voter.
