Abstract (en)  
Profile for finishing a joint (4) in a floor covering (1), wherein this profile consists at least of two parts (6-7), namely, a first part (6) which can be provided above the edge of the floor covering (3) and thereby covers said joint (4) at least partially, and a second part (7) which can be provided in said joint (4) for attachment of the profile (1), characterized in that an elastically deformable component (8) is connected to the profile (1), more particularly to said second part (7) thereof, wherein this elastically deformable component (8) is operative in said joint (4).
