[origin: WO2010012348A2] The invention relates to a process for producing a composite component (100), said process comprising the following steps: 1.1 a decorative composition (110) is produced from at least one backing layer (114) and at least one colour-imparting layer (112), 1.2 a structural composition (130) is produced from at least one top layer (132; 136) and at least one spacer (134) connected thereto, 1.3 a connecting layer (120) is introduced between the decorative composition (110) and the structural composition (130), and 1.4 the structural composition (130) and the decorative composition (110) are joined together, with the connecting layer (120) being cured.
