[origin: CA2733108A1] A household appliance (1), (17), such as a dish washer, a washing machine or the like, comprising a program control for controlling program sequences for at least one operational parameter, such as the temperature, pH value or the like, and/or the operation of at least one machine component, such as spray arms, pumps or the like, characterized in that the program control comprises a program mode for the use of a metering device (6) that is not permanently integrated into the household appliance (1), (17), wherein the program sequence thereof is adapted for at least one operational parameter and/or at least one operation of at least one machine component to the ability of the sensor of a metering device (6) that is not permanently integrated to control the metering on the basis of operational parameters and/or operations detected by the sensor.
