[origin: WO201009491A1] The invention relates to a lighting device which comprises at least two light-emitting diodes (1, 2) and a carrier element on which the light-emitting diodes (1, 2) are arranged, the carrier element (5) being designed as a polygon in which at least two lateral faces converge and the light-emitting diodes (1, 2) being arranged on the lateral faces of the carrier element (5).
