[origin: US2011050767A1] A web press, in particular a variable format book web press, variable format newspaper web press, or variable format periodical web press, has printing units (102a, 102b) having printing devices (109, 109a, 109b, 109c, 109d) or groups (119, 119a, 119b, 119c, 119d) of printing devices (109, 109a, 109b, 109c, 109d) for applying ink to a paper web (108). The printing devices (109, 109a, 109b, 109c, 109d) or groups (119, 119a, 119b, 119c, 119d) of printing devices (109, 109a, 109b, 109c, 109d) are constructed without rotating impression cylinders and are designed to apply ink to the paper web (108) in a noncontacting manner.
