[origin: CA2733543A1] The invention relates to a method and a device for drying and precondensing impregnation products (14) which are constituted of a resin-bonded film-type web material. According to the invention, the impregnation product (14) is irradiated with microwaves. The invention allows the production of impregnation products (14) which are suitable to be compacted with a base produced of a wood material although the impregnation resin is melamine resin-free.
