Abstract (en)

[origin: WO2009146444A1] A system and method for wirelessly transmitting audiovisual information. Training information may be stored in a memory. A plurality of packets may be generated, including the training information. The plurality of packets may also include audiovisual information. The plurality of packets may include first information identifying a first training pattern of a plurality of possible training patterns. The first training pattern may specify one or more locations of the training information in the plurality of packets. The first information may be usable by a receiver to determine the first training pattern of the plurality of possible training patterns. The plurality of packets may be transmitted in a wireless manner.
