Abstract (en)

[origin: EP2324769A1] An ultrasonic diagnostic apparatus having an ultrasonic probe for transmitting an ultrasonic beam to an examinee and receiving a reflection echo signal from the examinee, a beam forming unit for supplying the ultrasonic probe with a signal for making the ultrasonic probe transmit an ultrasonic beam, and a data converter for digitalizing the reflection echo signal to obtain echo data, and converting the echo data to ultrasonic image data including a setting unit that sets measurement mode data of the ultrasonic image data in the echo data, and a controller that creates a data set while appending the measurement mode data and the echo data, transferring the data set to the data converter, makes the data converter analyze the measurement mode data in the data set, and controls the data converter so that echo data in the data set are converted to ultrasonic image data on the basis of the analyzed measurement mode data.
