Abstract (en)

[origin: WO2010007273A1] The invention relates to a mixing process, a spraying and dispersing device and a mixing device for implementing the process. The process of mixing content (C) in a container (2), of the type in which a container (2) is provided which has means for introducing the components and mixing means (14), components of the content (C) are provided, and the components are then introduced into the container (2) and are mixed, is characterized in that on the one hand a mixing facilitator Fm is provided, a spraying and dispersing device (15) which can be joined to a container (2) at one of its introduction means is provided and can be in an active functional state in which it enables a liquid to be sprayed and dispersed into the container (2), and then, in a first phase, the content base (Cb) and then the component to be mixed (Cm) are introduced into the container (2) without filling it and, in a second phase, the mixing facilitator (Fm) is introduced into the container (2) through the introduction means (3) and is sprayed by dispersing it towards the component to be mixed (Cm) by means of said spraying and dispersing device (15) which is placed in the active functional state.
