Abstract (en)

The brush (310) has bristles radially extending around a portion of a metallic core. A recess (312) is extended on the half of the length of a portion of the brush carrying the bristles, where the recess has depth of 2.5 to 4 mm. A transversal section of the brush in a plane cutting the recess is non circular. The recess is formed on the portion of the brush, where the length of the bristles in a region of the recess is zero. Independent claims are also included for the following: (1) a device for conditioning and applying the product on the eyelashes and/or the eyebrows (2) a method for applying the product on the eyelashes and/or the eyebrows (3) a method for assuring make-up to the eyelashes and/or eyebrows.

Abstract (fr)

La présente invention concerne une brosse (310) pour l'application d'un produit sur les cils et/ou les sourcils, comportant : - une âme, - des poils s'étendant radialement autour d'au moins une portion de l'âme, à partir de celle-ci, et - au moins une encoche (312) qui s'étend sur moins de la moitié de la longueur de la portion de la brosse portant les poils, une section transversale de la brosse dans un plan coupant l'encoche étant non circulaire.
