Abstract (en)  
A method for mounting a gully in a floor configured for a floor covering and a device for providing, at this method, a recess in the floor for an inlet member of the gully are referred to. At the method, an outlet member (3) of the gully is mounted in the floor (1) for connection of the outlet member to a discharge system, a recess (4) for an inlet member of the gully is defined in the floor (1) in connection to the outlet member (3) of the gully, a sealing layer (6) is located on top of the floor (1) and the recess (4) therein and connected to the outlet member (3) of the gully, the inlet member (5) of the gully is located on top of the sealing layer (6) in the recess (4) in the floor (1) with flow connection to the outlet member (3) of the gully, and a floor covering is provided on the floor (1) and around the inlet member of the gully in close connection thereto. The device comprises a spacer piece which can be located on a lower part (1 b) of the floor (1) in connection to an outlet member (3) of the gully which is mounted in said lower part of the floor, which is configured to define a recess (4) by, after location of said spacer piece on said lower part of the floor, providing an upper part (1a) of the floor around the spacer piece, and which is configured, after the provision of said upper part of the floor, to allow removal of the spacer piece for exposure of said recess
