Abstract (en)  
The insert (10) has a moisture-wicking and air-permeable central sole part (14) made of material or a material mixture. An elastic sole frame (16) is made of another material or the mixture and partly surrounds the part that comprises a spacer fabric layer. The former material is polypropylene, polyethylene, nylon or a mixture of synthetic and natural fibers i.e. cotton. The latter material is polyurethane (PUR), latex, thermoplastic rubber, thermoplastic PUR elastomer or ethylene vinyl acetate. A coating of the frame and the part is made of fabric, fleece, microfiber or leather.

Die Erfindung betrifft einen Sohleneinsatz (10, 10', 10'') für ein Gehgerät, insbesondere einen Schuh, umfassend einen feuchtigkeitstransportierenden und luftdurchlässigen Sohlenzentralteil (14) aus einem ersten Material oder Materialgemisch und einen den Sohlenzentralteil (14) wenigstens teilweise umgebenden elastischen Sohlenrahmen (16) aus einem zweiten Material oder Materialgemisch. Ferner betrifft die Erfindung einen Schuh mit einem derartigen Sohleneinsatz (10, 10', 10'').
