Abstract (en)

The invention describes a device (20) for wall-mounting (22) a head (26) of a tubular gearmotor for awnings or the like, comprising a first element (50) able to be fixed to the wall and having a carrier seat (53) in which to receive and support the head (26) of the gearmotor, and a second element (80) suitable for blocking the head (26) to the first element (50). In order to simplify installation, the second element (80) is suitable for rotating between two angular positions and is configured to block or permit an axial withdrawal of the head (26) from the seat (53) in one or other of the two positions, respectively.
