Abstract (en)

The device (20) has a driving unit constituted of a wind vane body (26) and a sealed ball bearing (25) for driving a vertical wind-barrier shield (27) in rotation around an outlet section (221) of a smoke evacuation pipe (22) so as to orient the wind-barrier shield against the wind. The wind-barrier shield is mounted in rotation around an axle (24) integrated with an upper face (211) turned towards an exterior of a circular bonnet (21) fixed on the evacuation pipe. The wind-barrier shield and/or the body are made of stainless steel, thermosetting resin, composite material and/or carbon fibers.

Abstract (fr)

L'invention concerne un dispositif de protection (20) de la sortie d'un conduit l'évacuation de fumées (22) comprenant au moins un écran pare-vent (27) sensiblement vertical. Selon l'invention, un tel dispositif de protection (20) comprend des moyens d'entraînement dudit écran (27) en rotation autour de la section de sortie (221) dudit conduit (22), de façon à orienter ledit écran (27) face au vent.
