[origin: EP2003237A1] A dispenser (6) for dispensing detergent products or similar in a laundry washing machine (1), wherein the dispenser (6) has a drawer (7) housed in a front wall (4) of the machine (1) and divided into a front section (10) used for dispensing products manually and for housing single amounts of products, and a rear section (11) used for dispensing products automatically and for housing at least one container (12) containing a sufficient quantity of a relative product for a given number of washes.
