Abstract (en)

[origin: WO2010083980A1] The invention relates to a composite component made of at least (3) different material layers, having the following layer composition: a) carrier layer or carrier structure made of metal and/or fiber-reinforced plastic, b) bonding agent layer made of elastomer, c) cover layer made of carbon fiber-reinforced or mixed carbon fiber-reinforced plastic, wherein the plastic and the arrangement of the carbon fibers or mixed carbon fibers are chosen such that the carbon fibers or mixed carbon fibers are optically visible on the surface of the cover layer.
