Abstract (en)
A lubricating composition comprising (i) a Fischer-Tropsch derived base oil, and (ii) lubricant additive at a total level of at most 2% by weight, wherein the lubricating composition has a viscosity index of at least 140 and a kinematic viscosity at 40 °C of at most 100 mm²/s, and wherein the lubricating composition is essentially free of polymeric viscosity index improver. The lubricating composition of the invention exhibits improved extreme pressure and shear stability properties.
