Abstract (en)

Finishing for a staircase (2) or step, wherein this finishing (1) comprises at least a decorative strip (3) and a floor panel (4), wherein said floor panel (4) is provided with a profiled edge region (5) in the form of a coupling means (6), characterized in that said finishing (1) also comprises an adapting profile (32), wherein this adapting profile (32) cooperates with the body of said decorative strip (3) and the adapting profile (32) comprises a surface (33), which, at the location of said coupling means (6) of the floor panel (4), extends transverse in respect to the decorative side (18) of the floor panel (4), wherein this surface (33) shows a profile offering room for at least a portion of said coupling means (6).
