Abstract (en)
[origin: WO2010091838A2] The invention relates to a method for providing, in particular for providing and reprocessing a medical product, comprising a medical object, for example a medical instrument, which is stored in a package, in particular in a sterile manner, and issued to the respective user in said condition, characterized by the following steps: providing the medical product with an individual ID, providing the package of the medical object with a means for determining the packaging state as "package still unopened" or "package opened", determining the ID of the medical product, and storing the ID in a higher-level storage, wherein the steps (a) to (c) are executed in an organizational unit (13) placed before delivery, providing the medical product from the organizational unit (13) to the user, user-related determination, in particular at the user's end, of the ID of the medical product and storing the ID in a user-related storage, in particular at the user's end, and reconciling the user-related data and the data present in the higher-level storage.
