Abstract (en)  
An elevator speed governor, comprises : a base (14) installed within a hoistway (1); a pulley (13) rotatably supported by the base (14) and having a speed governor rope (12) looped around the pulley (13), for rotating in accordance with a raising/lowering speed of a car (2); a ratchet (26) provided with an engaging strip (27) for actuation, and capable of rotating around a pulley shaft (15) of the pulley (13); an engaging mechanism (30) having a pawl (28) , with which the pulley (13) is provided turnably between an actuation position for being engaged with the ratchet (26) and a release position for being disengaged from the ratchet (26), the pawl (28) being turned from the release position to the actuation position, and rotating the ratchet (26) in the same direction as the pulley (13) when a rotational speed of the pulley (13) has reached a set overspeed set in advance; an actuating lever (38) which is brought into abutment on the engaging strip (27) for actuation and displaced through movement of the engaging strip (27) for actuation resulting from rotation of the ratchet (26); and a rope holding mechanism (31) which is actuated through displacement of the actuating lever (38) resulting from abutment on the engaging strip (27) for actuation and brakes the speed governor rope (12) characterized in that the base (14) is provided with a groove portion (61) into which a part of the engaging strip (27) for actuation is inserted, the groove portion (61) extending in a direction so that the engaging strip (27) for actuation moves.
