Abstract (en)

The device has a pair of movable arc contacts (5, 6), and a compression chamber whose volume (V1) varies and opens in a blowing chamber under action of a blowing-piston (60). One of the arc contacts is indirectly linked to an operating rod by mechanical transmission units for obtaining a value of ratio of displacement speed of the movable arc contact and the operating rod greater than 1. The blowing chamber is integrated to the movable arc contact and a permanent arc contact (3), and a contact carrier tube (8) provides current to the permanent arc contact while movable arc contact is fixed.

Abstract (fr)

L'invention concerne une nouvelle chambre de coupure (1) à énergie de manoeuvre réduite. Selon l'invention, au moins un contact d'arc mobile (3, 5) est lié indirectement à la tige de manoeuvre (4) par des moyens mécaniques de transmission adaptés pour augmenter le rapport de vitesses en translation entre ledit contact mobile et la tige de manoeuvre et le piston de soufflage (60) est solidaire d'un contact d'arc (6) mobile et d'un contact d'arc permanent (3), le tube porte-contact (8) d'amenée du courant au contact permanent (3) mobile étant fixe.
