Abstract (en)

Front-loading washing machine that comprises a support (4), a drum (6) adapted to house a load, the load being any laundry, an opening (2) included in the support (4) through which the load is introduced in or removed from the inside of the drum (6), and a door (3) adapted to close the opening (2), the door (3) comprising a window (5) delimiting a cavity adapted to house at least part of the load. The front-loading washing machine comprises filling means (20) adapted to introduce a fluid into the cavity, and emptying means (30) adapted to empty the fluid housed in said cavity, so that the load housed in said cavity (13) is washed and/or treated.
