[origin: WO2010125013A1] The invention relates to a composite material having two or more superimposed wood layers. Said layers are joined together by means of a one component polyurethane adhesive containing a prepolymer having free NCO groups and a wood having a volume fraction of libriform fibres in the region of between 50 - 70 % is used.
