[origin: EP2426240A2] The wire mesh (1) comprises warp wires (2) and weft wires (3) on a mesh surface (4). Pipe connections are provided, which are woven on the mesh surface. Lamellar units (6) are provided, which are arranged at the pipe connections for shading of light. The pipe connections are designed as transparent pipes, into which the lamellar units are received.
