[origin: WO2010127411A1] The invention discloses a composition for treating pain and/or inflammation and for treating a skin or mucosal disease or condition comprising menthol, ginseng and an emollient. The invention also discloses a method for treating pain and/or inflammation or for treating a skin or mucosal disease or condition. The invention additionally discloses use of the composition in the manufacture of a medicament for treatment of pain and/or inflammation or for treatment of a skin or mucosal disease. The invention further discloses a composition for treating a skin disease and/or a skin condition comprising one or more stabilised alpha hydroxyl acid. Also disclosed are methods for preventing and/or treating a skin disease or skin condition including the steps of: treating an area of skin with one or more composition according to the invention; applying one or more photosensitizer to the area of skin; and exposing the area of skin to light to thereby prevent and/or treat the skin disease and or condition.
