Abstract (en)  
[origin: WO2010134883A1] System for securing a shelf accessory to a shelf, comprising a front securing device (20), a rear securing device (30) and a shelf accessory (10) having a front engagement member (11) configured for engagement with the front securing device, as well as a rear engagement member (40) configured for engagement with the rear securing device. The rear securing device comprises a first stop face (32a) and the rear engagement member comprises a second stop face (47), which first and second stop faces are configured to, in mutual contact, prevent the rear engagement member from being disengaged from the rear securing device when the shelf accessory is held substantially parallel with the top side of the shelf, and to allow the rear engagement member to be released from the rear securing device when the front end of the shelf accessory is lifted such that the shelf accessory has assumed an angle to the top side of the shelf.
