[origin: WO2010136333A1] The invention relates to an illumination module (2) having at least one flexible, particularly ribbon-shaped, carrier (4) for several heat sources, including light sources (6), wherein the carrier is intended to be bent across at least part of its width. The illumination device is provided with a curved base (9) and at least one illumination module, wherein the illumination module is flatly attached to the base with its widthwise curved part, at least sectionally.
