Abstract (en)
[origin: WO2010136169A1] The invention relates to a closed and encapsulated construction concept having minimized weight. According to the invention, an elevatable modular weapon platform (100) is used, allowing the integration of different weapons (11). Said platform (100) can thereby receive required ammunition containers (2) on the bottom side thereof, while carrying the weapon (100) on the top side (or vice versa). The integration of the electronic components can be provided in the side construction of the closed housing of the elevation bearing (3). Displaceable ammunition feeding channels can thereby be eliminated, because the transport can take place in rigid guideways and channels.
