Abstract (en)

The multifunctional wireless equipment for monitoring and protection of persons comprises at least one Personal Unit (1) evaluating the status of the monitored person and if the set sensor limits or combinations thereof are exceeded, the Personal Unit (1) sends a signal or data information to the Receiving Unit (4). The Personal Unit (1) is activated or deactivated by the Control Unit (2) and it may be equipped with a backup signal source. The equipment also comprises at least one Parallel Unit (3) monitoring the Personal Unit (1), stores information thereof and sends a signal or data information to the Receiving Unit(s) (4) in case of outage of connection with the Personal Unit or exceeding of the monitored parameters. The equipment supports definition of geographic areas so that the Parallel Unit (3) sends a signal or data information to the Receiving Unit (4) independently on the Personal Unit (1) in case of departure from a pre-defined geographic area for a time exceeding the set limit.
