[origin: CA2770067A1] The invention relates to a carrying device for a baby or a small child (2), comprising a retaining harness system and an accommodating element (16) connected to the retaining harness system. At least one end area (13) of the accommodating element (16) extends at least to the retaining harness system and is adjustably connected to the retaining harness system, whereby the accommodating space (3) can be adapted to the size of the baby or small child (2) to be carried.
