[origin: WO2011018459A1] The present invention relates to a coated microfibrinous web, a method for producing the same, use thereof as a covering of a radiation protection material and also a radiation protection device. The coated microfibrinous web comprises: (i) a microfibrinous web which is impregnated with a fluoropolymer; and (ii) a layer comprising polyurethane, which is present only on one side of the microfibrinous web.
