Abstract (en)

The capsule for infusion products (1) comprises a cup-shaped structure (2) made of plastic material defined by a bottom wall (4) provided with through holes (13) and by a side wall (3), and a lid (21) made of plastic material arranged so as to close said cup-shaped structure (2) and presenting a peripheral edge (25) welded by means of an ultrasonic welding device upon an upper part (6) of the above said side wall (3). The upper part (6) of said side wall (3) presents from the bottom towards the top a first annular section (16) and a second annular section (17) of an external diameter smaller than the one of said first section (16). The peripheral edge (25) of the lid presents a first annular section (26) facing the second section (17) of the upper portion (6) and a second annular section (27) folded downwards and facing the first section (16) of the upper portion (6) so as to constitute an holding organ of possible molten material deriving from the welding between said first section (26) of the peripheral edge (25) and the second section (17) of the upper portion (6).
