Abstract (en)

The invention relates to a staining kit for staining valuables, in particular banknote paper, and an apparatus and method for staining valuables. The staining kit comprises at least one adhesive composition, comprising polymerizable adhesive monomers capable of forming a polymer adhesive upon activation; at least one colorant composition, comprising at least one colorant, capable of yielding an adhesive-bound colorant with the adhesive composition; and at least one adhesive crosslinker, capable of activating the adhesive monomers when contacted with the adhesive composition.
