[origin: EP2469964A1] A mobile terminal for implementing monitoring management is disclosed in the present invention. The mobile terminal includes a user danger level monitoring platform configured to adapt to a monitored current situation of a user, enable a corresponding danger level and take a corresponding rescue measure. A method for implementing monitoring management is also disclosed in the present invention. The method includes adapting to a monitored current situation of a user, enabling a corresponding danger level and taking a corresponding rescue measure. With the mobile terminal and the method of the present invention, it is possible to monitor the user request for help in real time and to take the corresponding rescue measures in time according to the different needs faced by the user, and win the rescue time.
